### **ORDER**

This order may be read with reference to the previous order dated 1.10.2018 vide which the respondents were directed to file an affidavit stating that there is no report of patwari with the sale deed. The case was adjourned to 01.11.2018.

2. On 01.11.2018, in compliance to the previous order, the respondent placed on record statement/affidavit of Shri Joginder Singh, Sub Registrar-cum-PIO, Jagraon on the record of the case file, the contents of which are as under:-

(5). ਇਹ ਕਿ ਆਪ ਜੀ ਵਲੋਂ ਪ੍ਰਾਰਥੀ ਨੂੰ ਜੋ ਟੀ.ਐਸ.1 ਸਰਟੀਫਿਕੇਟ ਦੇਣ ਬਾਰੇ ਹੁਕਮ ਕੀਤਾ ਗਿਆ ਹੈ, ਉਸ ਬਾਰੇ ਕਾਰਜ ਸਾਧਕ ਅਫਸਰ, ਨਗਰ ਕੌਂਸਲ, ਜਗਰਾਊਂ ਨੂੰ ਇਸ ਦਫ਼ਤਰ ਦੇ ਪੱਤਰ 296/ਆਰ.ਸੀ. ਮਿਤੀ 29.10.2018 ਰਾਹੀਂ ਪ੍ਰਾਰਥੀ ਨੂੰ ਦੇਣ ਬਾਰੇ ਲਿਖ ਦਿਤਾ ਗਿਆ ਹੈ।

3. The appellant expressed dis-satisfaction with the reply/affidavit filed by the respondent-PIO in the office of the Commission. He stated that it is mentioned on the sale deed itself that report of Patwari is attached. Accordingly, it was directed that report of Patwari, be provided to appellant, if the same is not available in the record, then inquiry be conducted who has misplaced the same. Besides, a compensation of Rs. 2000/-was awarded to the appellant for the loss and detriment suffered by him and a Show-Cause Notice was issued to the PIO for the delay in the supply of information. The case was adjourned for today.

4. A letter No. 319/RC, dated 26.11.2018 has been received from PIO-cum-Sub Registrar Jagraon vide which it has been informed that the photo copies of all the documents, available in their office, have been provided to the appellant and an affidavit in this regard has also been submitted to the Commission.

5. Today, the representative of the respondents hands over a Bank Draft of Rs. 2,000/- as compensation amount to the appellant. The appellant reiterates that he wants copies of documents on the basis of which registry has been done. He further states that he wants copy of Plan and report of Patwari. Accordingly, it is directed that requisite documents be supplied to the appellant and in case these are not available then an inquiry be conducted to look into the missing of record and fix responsibility for the same. In case, any malafide is proved, further necessary action under the law be initiated. It is also directed that a copy of affidavit submitted by the PIO be provided to the appellant.

In this case, Dr. Bhagwan Singh, Appellant, vide his RTI application dated 09.10.2016, addressed to the Home Secretary, Punjab, Chandigarh, sought certain information on 4 points regarding murder case of Sant Harchand Singh Longowal and murder case of Shri Gurdev Singh Kaonke, Acting Jathedar of Akal Takht Sahib. The Home Department transferred RTI application of the applicant to Director General of Police, Punjab, Chandigarh vide Memo. No. 6/79/16-2H4/861082/1, dated 18.10.2016 for supplying the requisite information to the applicant.

2. A letter No. 75-Appeal/RTI, dated 21.07.2018, along with a copy of FIR,

was received from S.S.P. Sangrur vide which it had been informed that Case No. 98, dated 20.08.2018 was registered at Police Station Sherpur under Sections 302/307/34 and copy of FIR had been supplied to the appellant. It had also been informed that except FIR there was no other record available with them. Accordingly, during hearing on 01.10.2018, it was directed that a copy of letter No. 75-Appeal/RTI, dated 21.07.2018, along with a copy of FIR, received from S.S.P. Sangrur be sent to the appellant. Besides, the PIO of the office of Director General of Police, Punjab, Chandigarh was directed to submit report on the next date of hearing regarding setting up of Commissions with regard to the said murders. The case was adjourned to 01.11.2018.

3. On 01.11.2018, none was present on behalf of the PIO of the office of Director General of Police, Punjab, Chandigarh without intimation and nothing had been received from him. Therefore, he was directed to comply with the previous order of the Commission dated 01.10.2018 and send report regarding setting up of Commissions with regard to the said murders before the next date of hearing failing which punitive action would be initiated against him.

4. The appellant was not present during second consecutive hearing. With the previous order dated 01.10.2018 copies of letter received from Senior Superintendent of Police Sangrur dated 21.07.2018 and FIR were sent to the appellant, which might have been received by him but no observations had been received from him. Accordingly, last opportunity was afforded to the appellant to appear before the

Commission for defending his case or send observations before the next date of hearing, failing which it would be presumed that appellant had nothing to say and the case would be decided on merits on the basis of record available on the case file. The case was adjourned for today.

5. Today, the representative of the respondents submits a letter No. 3502/C.B.-4, dated 29.11.2018 from AIGP Admn-cum-PIO, Crime office of Bureau of Investigation, Punjab, Chandigarh vide which it has been informed that reply has already been sent by S.S.P. Sangrur . It has been further informed by AIGP Admn-cum-PIO that no more information is available in their office.

6. As per the orders of the Commission passed on the last date of hearing, Dr. Bhagwan Singh, Appellant is present along with his Counsel Shri Kabul Singh , Advocate. He states that Commissions were set up to look into the said murders but no information has been supplied to him so far. Accordingly, the PIO of the office of Additional Chief Secretary, Home Affairs and Justice is impleaded as a necessary party in this case. The PIO of the office of Home Department and the PIO of the office of Director General of Police, Punjab, Chandigarh are directed to file point-wise reply on the next date of hearing on the basis of facts/documents available in their offices.
