ORDER:

1. The RTI application is dated 20.07.2019 vide which the appellant has sought information as enumerated in his RTI application. 3. The appellant states that he had asked for the information from the PIO regarding the enquiry report submitted by the District Education Officer, Ludhiana which was marked to him by D.C. 4. On the asking of the Court, the APIO Sh. Amarjit Singh, Supdt. has stated that no enquiry report from the D.C. Ludhiana has been received by them. On this, his attention has been drawn to the clarification given by the Appellant regarding the enquiry report submitted by the D.E.O. Ludhiana, upon which he admitted to having received the same. He however, clarified that the said enquiry report is still under process and is yet to be finalized.

5. The Commission has shown its concern for the delay caused in the supply of information to the Appellant and directed the PIO to supply the information to the Appellant in the form
