**ORDER**

The brief fact of the appeal case is that the appellant filed RTI with the PIO, o/o CDPO, Block Guruharsahai, Distt. Ferozepur. First appeal was filed with FAA and second appeal was filed in the Commission on 29.10.2018 under Section 19 of the Right to Information Act, 2005. Notice for the first hearing was issued on 03.12.2018.

During the hearing dated 03.12.2018, the respondent was absent and the appellant Sh. Veer Singh stated that no information has been given to him. Accordingly the appeal was adjourned on 10.01.2019. On that date i.e. 10.01.2019, again the appellant stated that no information has been given to him and the respondent was absent therefore the appeal was adjourned on 05.02.2019 i.e. today. Today, again the respondent is absent and the appellant states that no information has been given to him so far.

The perusal of the file shows that today the respondent is absent for third consecutive hearing. The appellant and his representative have attended three hearings in the Commission. The appellant has, therefore, suffered mental harassment and financial loss in attending the hearings in the Commission. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be

compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.5000/- (Rupees Five Thousand Only)** is awarded to the Appellant as compensation. I order accordingly.

This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.
