After examining the documents placed on record, it is found that the respondent PIO through a reply vide letter no. 4603 dated 04.02.2020 signed by Secretary, Regional Transport Authority, Bathinda, which has been received in the Commission through an e-mail, has intimated the Commission that he is unable to attend today's hearing due to sudden demise of his elder brother and requested for an adjournment in this case. It is taken on record.

After examining the documents placed in the case-file, it is emerges that the information sought for by the appellant through RTI request relates with office of Secretary, Regional Transport Authority, Bathinda and accordingly the RTI request of the appellant was transferred by Public Information Officer office of State Transport Commissioner, Punjab, Chandigarh to the said office under section 6 (3) of the RTI Act vide letter no. 185516 dated 27.12.2018. Accordingly, on the hearing, held on 16.10.2019 PIO of office of Secretary, Regional Transport Authority, Bathinda was impleaded as necessary party in this case and the respondent-PIO concerned was directed to supply the certified copies of the required information to the appellant through registered post.

An opportunity is also given to the appellant to confirm whether he has received the information or not. He is also advised to point out deficiencies, if any, in the information supplied to him, in writing, to the respondent PIO so that the same could be removed by the respondent concerned.
