ORDER

This order may be read with reference to the previous order dated 07.01.2020 in which it is mentioned that complete information was sent to the appellant alongwith its annexures. The appellant was advised to go through the same and revert back to the authorities in case of deficiencies in the information provided to him.. Affidavit given by Shri Lal Singh, BDPO, Block Valtoha was taken on record of the case file and that matter was kept pending to be decided on the next date of hearing. This Commission also sent a copy of the information placed on its record to the appellant with the order dated 07.01.2020.

2. The appellant is absent without intimation.

3. The respondent-PIO states that complete information has been provided to the appellant. Shri Lal Singh, BDPO, Valtoha has explained reasons of delay in supplying the information to the appellant in his affidavit, which was placed on the record of the case file. Shri Lal Singh stated in his affidavit that grant-in-aid of Rs.120000/- was received by gram panchayat. He was appointed as Administrator of the said panchayat because quorum of panchayat was not complete, He further stated that the work of laying of sewerage line was started but some persons with their vested interests have disrupted the work. After some time, the work of laying sewerage line was taken up after some time. After completion of the work of laying sewerage line,

measurement was done again and the information was provided to the appellant. The representative of the respondent states that one more copy of the information placed on the record of the Commission was again sent to the appellant through registered post.

4. After hearing the respondent-PIO and going through the record available on the case file, it is ascertained that complete information has been provided as per its availability on the record of the respondents and nothing has been left, which could be supplied to the appellant. The appellant is absent without intimation. In compliance to the previous order, the appellant has not sent any deficiency in the information supplied to him. In view of this, the present case is disposed of and closed with the advice to the appellant to revert back to the authorities, in case of deficiencies in the information supplied to him, with a copy to the Commission within 10 days from today. The Commission is satisfied with the explanation given in the affidavit placed on the record of the Commission to the Show cause notice issued to Shri Lal Singh, BDPO, Valtoha for imposition of penalty and award of compensation to the appellant. Hence, it is withdrawn in view of the affidavit given by him. Copies of the order be sent to the parties.

ORDER
