The RTI application is dated 3.9.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter called FAA) on 3.10.2020 and second appeal was filed in the Commission on 24.11.2020 under Section 19 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for 18.2.2021 but due to administrative reasons the case was adjourned for today i.e. 5.3.2021.

2. The appellant states that no information has been provided by the respondents so far. However, the representative of the respondents states that the office of the Deputy Commissioner, Amritsar transferred the RTI application under Section 6(3) of the RTI Act, 2005. He also states that the sought information as available on record has already been supplied to the appellant. Furthermore, the appellant states that the rest of the information has to be supplied by the Public Information Officer o/o the Deputy Commissioner, Amritsar. He has also sent a letter bearing No. 594 dated 16.2.2021 in this regard, which is taken on record.
