ORDER:

1. The RTI application is dated 20.12.2020 vide which the appellant has sought information as enumerated in his RTI application. The first appeal was filed with the First Appellate Authority (hereinafter FAA) on 05.01.2021 and the second appeal was filed in the Commission on 09.03.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
