

On the other hand, Sh. Jasvinder Singh (AO) states that the record was not handed over by Sh. Satish Kumar to the concerned person at the time of relieving due to which information could not be supplied.

On this, the AO, Sh. Satish Kumar states that it was his temporary appointment done by Chief Agriculture officer due to which no charge was taken or given by him. He further states that all files was checked and were tally by the then Sub Inspector, Sh. Sukhdev Singh as he left the concerned office in 2016.

On further discussion it has been found that there is no receipt of submission of record to the concerned person.

Commission takes a very serious view against the working of the office of The Chief Agriculture Office, Fatehgarh Sahib as the record is not maintainable in proper form and the concerned information is still not traceable.

In view of above, a copy of this order along with the RTI application be sent to the FAA office of The Director, Agriculture and Farmer's Welfare Department, Punjab and he is further directed to look into this matter and make sure the concerned PIO should supply the requisite information as per RTI to the Appellant by the next date of hearing.

The PIO concerned is directed to supply the information to the Appellant as per RTI application by registered post or email before the next date of hearing positively and if the information is not available with them then the PIO is directed to file a proper reply vide which explaining the reason/ status, why the information could not be supplied to the Appellant till date.

The PIO concerned is also directed to submit the copy of the postal receipts to the Commission vide which information would have been supplied to the Appellant, by the next date of hearing.

Also, the Appellant, Sh. Ram Singh is directed to go through the supplied information and point out deficiencies in written, if any, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which it would be presumed that he has nothing to say and the case would be decided on merits.

A copy of this order be sent to the Additional Chief Secretary (Development), Punjab and he is further advised to look into the working of the office of The Chief Agriculture Office, Fatehgarh Sahib.

ORDER:

This case may be read with the reference of the previous order dated 20.04.2022, vide which both the parties requested for the adjournment and matter was fixed for today i.e. 05.07.2022.

In today's hearing, representatives of both the parties are present.

On asking the representative of the Appellant, Advocate, Sh. Gurnoor Sandhu states/intimates that, Sh. Harinder Singh is not ready to take back the allegations which were levied by him on the State Information Commissioner, Punjab, Ms Preety Chawla.

After hearing the representative of the appellant and examining the documents placed on record, it is observed that on hearing held on 24.01.2022, an opportunity was given to the appellant, to take back the allegations, in writing, which were levied by him against the then Hon'ble State Information Commissioner, Ms. Preety Chawla, by the next date of hearing so that further hearing/hearings in the instant appeal case could be held."

In view of above, allegations, in relation to the Commission/Commissioners, it is clarified that the Commission is a constitutional body. It is disgraceful to write without a solid basis/document. While deciding other appeals, this bench had made very candid and express observations asserting that this bench is bound by an oath of allegiance to the Constitution of India to discharge its duties without fear or favor. The Commission is duty bound morally and ethically to take decisions without bias or ill-will against anyone.

Commission has taken serious notice for such false allegations against Commission/Commissioners, Ms. Preety Chawla, which is unbearable and the appellant has defamed the Commission by doing so.

As appellant is not agreeing to take back allegations, accordingly I could not hear this case. Therefore, this case file is sent to the Registry Branch of the Commission to put before the Hon'ble Chief Information Commissioner, Punjab for appropriate orders.
