Shri Raj Kumar, appellant filed RTI application dated 20.11.2019 and sought some information from the PIO, O/o. Managing Director, MARKFED, Chandigarh. When no information was provided to him by the PIO, then he filed First Appeal before the First Appellate Authority on 31.12.2019. Then he filed Second Appeal before the Punjab State Information Commission on 23.03.2020. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today to be **heard through CISCO WEBEX MEETINGS Software.**

Both the parties are present today. I have gone through the RTI application dated 20.11.2019 and also discussed about the sought for information with both the parties.

The Commission has received an e-mail sent by the PIO, which is a copy of letter no.120 dated 10.07.2020 along with a copy of letter no.2406 dated 10.07.2020 and a copy of letter no.1926 dated 15.06.2020. I have gone through the said letters.

The appellant stated that he has received the information, but he is not satisfied with the information. On the other hand the PIO stated that all the documentary information, which was available in the office of the PIO has already been provided to the appellant, but the appellant has put up some queries in his RTI application, which are not permissible under the provisions of the RTI Act, 2005.

As the PIO has provided the sought for information to the appellant and appellant has received the information, so the present appeal case is **disposed of and closed**.
