ORDER

1. This order may be read with the reference to the previous order dated 18.05.2021 vide which respondent, ASI, Ramesh Kumar stated that appellant demanded information in connection with ਦਰਖਾਸਤ ਨੰਬਰ 316893 ਮਿਤੀ 08.05.2013 through RTI application dated 14.01.2021, which is still under investigation before the ਮੁੱਖ ਅਫਸਰ, ਥਾਣਾ ਡਾਬਾ, ਲੁਧਿਆਣਾ, so requisite information could not be supplied to the appellant and reply in this regard has also been sent to him vide letter no.345-FA dated 22.12.2020. He added that an email dated 17.05.2021 is also sent to the undersigned bench in this regard (which was received by the undersigned bench comprising two letters 478 dated 14.05.2021 and 345-FA dated 22.10.2020). This email was taken on record.

Appellant was absent without any intimation. A last and final opportunity was given to the appellant to represent his case, failing to which case will be closed. Matter was adjourned for further hearing on 05.08.2021 i.e. today.

2. In today's hearing, representative of the appellant, Sh. Gurpreet Singh Kaler states that he is not satisfied as name of the concerned office is not supplied by the respondent PIO, where matter is under investigation.
3. Respondent, Sh. Ramesh Kumar states that matter is under investigation before the ਮੁੱਖ ਅਫਸਰ, ਥਾਣਾ ਡਾਬਾ, ਲੁਧਿਆਣਾ and reply has already been supplied to the appellant.
4. After hearing both the parties and examining the documents placed on record, it is observed that reply of the pointed out deficiency (regarding name of the concerned office where investigation is pending) has already been mentioned in the reply to the appellant vide letter no. 345-FA dated 22.12.2020 sent by the respondent PIO and in the previous orders of the Commission passed by in the present case dated 18.05.2021. I am of the considered view that supplied reply is satisfactory. Therefore, no further cause of action is required. Hence, this instant appeal case is **disposed of & closed**.
