"Since the complainant, respondent are the same and the information sought for is almost identical, the single order shall dispose of both the complaints.

The complainant had sought information about the income having accrued and the expenditure incurred during the incumbency of the former sarpanch of village Chaura, Block Sri Hargobindpur, Tehsil Batala, District Gurdaspur from 2013 to 2018. Sh. Narinder Singh, Panchayat Secretary appearing on behalf of the respondent says that the information is quite voluminous. Nonetheless, it has partially been delivered on the complainant. He assures to provide the rest expeditiously. The complainant also seems in agreement with the contention of the respondent."

The case has come up today. The complainant says that despite having assured during the course of hearing on the previous date the respondent has refused to provide him the information.

The PIO is, thus, issued a show cause notice to explain in a self- attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay / denial of the information to the RTI applicant and why the compensation be not awarded to the Complainant under Section 19 (8) (b) of the Act for the detriment suffered by him.

In addition to the written reply, the PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on

the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte."

"The cases have again been taken up today. The incumbent Panchayat Secretary Sh. Narinder Singh submits that the original record continues to be retained by one Sh. Dalbir Singh his predecessor who has not passed it on his transfer. He has also shown us some communications issued by the BDPO, Sri Hargobindpur in this regard.

The Commission takes a very serious note of the conduct of the respondent. The show cause notice issued earlier is now directed at Sh. Dalbir Singh, PIO – cum – Panchayat Secretary, O/o BDPO, Dhariwal who shall explain his conduct for not parting with the record and show cause as to why the penalty proposed should not be imposed upon him for willful and malafide suppression of information. Both Sh. Narinder Singh and Sh. Dalbir Singh, Panchayat Secretaries are directed to file their written replies also before the next date of hearing".

04.06.2019

"Sh. Narinder Singh, Panchayat Secretary, representative of the respondent, submits that almost the entire record has been provided to the complainant. The Commission observes that the Show Cause Notice already issued on 24.01.2019 was directed against Sh. Dalbir Singh, PIO-cum-Panchayat Secretary, O/o BDPO Dhariwal. He has failed to explain the delay and reasons for providing the information. The Commission is well within its right to impose penalty even at this juncture. However, final opportunity is afforded to Shri Dalbir Singh, Panchayat Secretary to submit in writing as to why the penalty mentioned in the show cause notice should not be imposed. Be it noted that no further opportunity shall be given to him."

25.07.2019

"The case has come up today. Shri Dalbir Singh, Panchayat Secretary,

despite having earlier been issued a couple of notices has refused to disclose the information and attend the hearings in the court. Show cause Notice was issued to him on 04.06.2019 for imposition of penalty for having violated the provisions of Section 7(1) of the RTI Act.

He has not come up with any explanation much less a valid one. The delay is beyond 100 days as can be made out from the chronology of filing applications and appeals mentioned above. He is culpable for being penalized. Therefore, exercising its authority under Section 20(1) of the Act, the Commission imposes a penalty of Rs.25,000/- @ Rs.250/- per day for 100 days to be recovered from his salary by the BDPO Dhariwal in 5 equal installments commencing from the month of September, 2019. It shall be deposited in the Govt. treasury under the head: - 0070-Other Administrative Services- 60 Other Services-800 Other Receipts-86 Fee under RTI Act, 2005. A copy of the challan shall be sent to the Commission for record immediately.

The aforesaid PIO has shown grave misconduct and indiscipline. His appointing authority is desired to issue him charge sheet and take appropriate action as per rules governing his service conditions.

The information has to be provided, he cannot get away with the same. The Commission while exercising the powers vested in it under Section 18(7), issues a bailable warrant for a sum of Rs.25,000/- and directs the Senior Superintendent of Police, Gurdaspur to serve it upon him so as to appear in the office of Commission on 05.09.2019 at 11.30 AM with the original record."

Sh. Dalbir Singh, Panchayat Secretary, is not present. The bailable warrant issued to ensure his presence in the court has also not been returned by the police authority. The Senior Superintendent of Police, Gurdaspur, is issued a reminder to do the needful. The following order was made by this forum on 23.07.2019:

"The complainant is aggrieved with the inaction of the police on complaint filed by her against one Master Manoj for having thieved her mobile phone, which according to her is highly priced. The respondents are absent and no written reply has been filed by them. The Commission takes serious note of their absence. They are directed to provide the information to the complainant immediately under intimation to the Commission, failing which the Commission shall be constrained to take penal action against them."

"The case has come up today. The respondent represented by Constable Sunil Kumar submits that original complaint was marked to one Sh. Raj Kumar, ASI who has yet to apprise the police station authorities of the action having been taken on the same. The respondent seeks sometime to inform the complainant.

they are looking into the matter. The respondents have not even bothered to file a written

The Commission feels the PIO is willfully obstructing the flow of information in

chairman of Block Samiti and is not in the position to join the proceedings. It has also been



"The appellant, vide his original application dated 24.12.2018, has sought to know the information about the details of nominations made for the election of Sarpanch and Panches of Gram Panchayat of Village Peer Mohammad, Block Makhu, District Ferozepur and the documents relating to the acceptance or rejection of their nomination papers. Having failed to find response even after filling first appeal with the DDPO, the appellant has been constrained to file 2nd appeal with the Commission.

The Commission has received a memo from BDPO Makhu to the address of SDM Zira to respond to the Commission's notice. The Commission is not inclined to approve the conduct of the BDPO who, apparently, has violated the provisions of RTI Act. The DDPO surprisingly has also failed to discharge his duty as First Appellate Authority which the Commission decries vehemently. In case the information is not available with him, the BDPO should have transferred the application to the concerned authority under Section 6(3) of RTI Act. Having failed to do so, he has made himself liable for penal action under Section 20(3) of the RTI Act.

Since the appellant and the respondents are same and the information concerns and emanates from the same incident, the single order shall dispose off all the appeals.

apprehension of breach of peace or imminent threat of life and liberty of anybody.


In order to arrive at just conclusion the appellant is desired to respond to the
