

Present : Sh. Rakesh Kumar Gupta, the appellant in person. Sh. Manohar Singh, Executive Officer-cum-PIO, in person.

<u>ORDER</u>

Heard through facility of Software/application 'CISCO Webex Meetings'. The RTI request is dated 25.05.2018. First appeal is dated 27.07.2018.

Second appeal has been received in the Commission on 09.10.2018.

On the last date of hearing, held on 27.07.2020, Sh. Abhay Joshi,

Accountant, who appeared for the respondent PIO, intimated that inspection of the relevant official record was done but the appellant had not identified any information from the case-file of the instant appeal case and demanding documents other than the documents placed in the case-file. An opportunity was given to the appellant to specify the required information, connected with the RTI request in this particular case, in writing, and send the same to the respondent PIO concerned so that information could be provided to him. Last and final opportunity was given to the respondent PIO concerned to supply the required information (which would be specified by the appellant in this particular case), as per record available in the instant appeal case-file, to the appellant well in time and send forwarding letter of the same with acknowledgement receipt signed by the appellant to the Commission. An opportunity is also given to the appellant to intimate the Commission whether he has received the information, which would be supplied to him by the respondent PIO concerned.

<u>ORDER</u>
