ORDER:

- 1. The RTI application is dated 14.07..2021 vide which respondent Sh. Jaspal Singh stated that the appellant demanded information relates with CCTV cameras and reply had already been supplied, stating that as per Section 8 (1) (j) requisite information cannot be supplied for the sake of security purpose of the citizens. Respondent PIO was directed to provide the number of cameras only to the appellant before the next date of hearing positively. Matter was adjourned for further hearing on 05.10.2021 i.e. today.
