After going through the documents placed on record, it is found that the appellant has inadvertently sought information from PIO of different office then the concerned PIO i.e. PIO O/o Improvement trust Amritsar therefore the appellant is advised to file a fresh RTI, to concerned department, as the PIO O/o Commissioner, cum XEN – 4 (C), Municipal Corporation Amritsar has filed satisfactory reply. Therefore, no further action is required in this case and hence, the instant appeal case is **disposed of and closed**.
