ORDER

In this case, during hearing on 11.09.2018, the appellant was awarded a compensation of Rs.2000/- (Rupees two thousand only) under Section 19(8)(b) of the RTI Act, 2005 for the loss and detriment suffered by him. The case was adjourned to 15.10.2018, which was further postponed to 06.12.2018 due to certain administrative reasons.

2. On 06.12.2018, the appellant informed that he had received a cheque of Rs.2000/- (Rupees two thousand only) as compensation alongwith information running 13 pages. He requested for adjournment to go through the provided information and revert back to the authorities, in case of any deficiency. Besides, he submitted a letter dated 17.11.2018, a copy of which was handed over to the representative of the respondent-PIO to go through the same and send point wise reply to the appellant with a copy to the Commission.

3. The representative of the respondents placed on record a copy of letter dated 14.11.2018, the relevant contents of which are as under:-

4. During hearing of the case, it came to the notice of the Commission that there had been some remissness in the office of the Additional Chief Secretary to Government of Punjab, Departments of Local Government, Chandigarh in the matter of receipt / taking of appropriate action on the RTI application sent to it. It was observed that this matter required a thorough probe by Additional Chief Secretary to Government of Punjab, Department of Local Government. Accordingly, it was directed that a thorough inquiry into this matter be conducted

by him to fix the responsibility of the official/s, who is/are responsible for the lapse and suitable disciplinary action against the delinquent officer/official(s) be taken as contemplated under Section 20 (2) RTI Act 2005. The case was adjourned for today.

5. Today, the representative of the respondents informs that a report regarding 2 points has been provided. He further states that file has been put up to the competent authority for conducting inquiry as per the orders of the Commission.

6. The appellant informs that the name of payee on the draft of compensation amount of Rs. 2,000/- is incorrect. He requests that the same may be corrected.

7. In view of the callous and lackadaisical attitude being adopted by the PIO in this case and in view of the loss and detriment suffered by the appellant, a compensation of Rs. 10,000/- more is awarded to the appellant to be paid by the Public Authority, which means that a total compensation of Rs. 12,000/- will be paid to the appellant through a Bank Draft before the next date of hearing. Besides, Principal Secretary, Local Government, Punjab, Chandigarh is directed to conduct an inquiry into the matter and submit report on the next date of hearing.

8. A copy of the order is forwarded to Principal Secretary, Local Government, Punjab, Chandigarh to ensure the compliance of the orders.

ORDER

The case was last heard on 08.01.2019, when during hearing of the case it had been brought to the notice of the Commission by the representatives of the respondents that there was a marital dispute of the appellant with her in-laws and on reaching a compromise between the parties for Rs. 11 lakh, the FIR was quashed by the Hon'ble Punjab and Haryana High Court on 19.12.2014. Thus it seemed that there was nothing left for dragging the matter any further.

2. Shri Shiv Dadwal, Senior Assistant, Judicial-1 Branch, submitted a Memo. No. 5/24/2018-2Judicial-1 Branch/64, dated 07.01.2019 from PIO of the office of Home Affairs and Justice(Judicial-1 Branch), with a copy to the complainant, vide which it had been informed that the application of the appellant had been considered by the Home Department and specific orders had been passed. It had also been informed that the application of the appellant had

been filed and the appellant had been informed vide Memo. No. 5/24/2018-2 Judicial(1)/2915, dated 31.12.2018.

3. Besides, the RTI legislation/regime does not provide any mechanism/forum for redressal of personal grievances. Therefore, the complainant was advised to pin-point any specific information available with the concerned PIO, which had not been provided to her so far. She might do so, in person, on the next date of hearing, otherwise case would be decided on merit. The case was adjourned for today.

4. Today, none is present on behalf of the complainant as well as the respondent. However, a letter dated 01.02.2019 has been received from the complainant on 05.02.2019 vide which no specific information has been asked for nor any specific deficiency in the provided information has been pointed out.

5. In these circumstances, the instant case is **disposed of and closed** with the directions to the complainant to ask for specific information by filing a fresh RTI application with the concerned PIO.
