ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 08.07.2019. First appeal is dated 08.08.2019. Second appeal has been received in the Commission on 26.11.2019.

On the last date of hearing, held on 18.11.2020, the appellant, Sh. Sarabjeet Singh Gill (himself) only was advised to visit the office of the respondent PIO on 09.12.2020 to collect the required information.

Sh. Harjit Singh, S. D. O. (Zone- B), who appeared on behalf of the respondent PIO in today's hearing, states that he (himself) was present the whole day in the office on 09.12.2020 and the appellant, Sh. Sarabjeet Singh Gill, did not visit the office on 09.12.2020 as directed vide orders dated 18.11.2020.
