The RTI request is dated 29.10.2019. First appeal is dated 02.12.2019. Second appeal has been received in the Commission on 21.01.2020.

On the last date of hearing, held on 12.10.2020, the respondent PIO concerned was directed to comply with the orders dated 04.08.2020 passed by the Commission by depositing penalty of Rs. 5000/- (Rupees Five Thousand only) in the Treasury of Punjab Government and to supply the required information to the appellant as per queries raised by him through RTI request. A copy of this order was sent through registered post to the Commissioner, Municipal Corporation, Ludhiana to ensure presence of the concerned PIO of office of Municipal Corporation, Ludhiana on the fixed date of hearing and also to ensure compliance of the above-said order.

The appellant, Sh. Gurmej Lal, who appeared in person in today's hearing, states that incomplete information has been supplied to him by the respondent PIO.

Sh. Satish Kumar, Assistant Town Planner-cum-PIO, who appeared in person, in today's hearing, states that in response to the RTI request, available information has been supplied to the appellant and part information, demanded by the appellant through RTI request is voluminous in nature, hence, could not be supplied to him as he has demanded action taken report on a complaint filed by him on 01.11.2019, which is regarding record of 81 buildings and if the appellant would be more specific for what he demands, information would be provided to him positively.

The appellant is advised to give name of 15 buildings to the respondent PIO within a day or two, so that the requisite information could be provided to him. He is also advised to visit the office of the respondent on 13.01.2021 during working hours to collect the required information.

The respondent PIO is directed to provide the information regarding 15 buildings, which would be specified by the appellant during his visit on 13.01.2021 in the office of the respondent.

An opportunity is given to the appellant to confirm whether he has received the information or not.

Sh. Satish Kumar, Assistant Town Planner-cum-PIO, also intimates the Commission that penalty of Rs. 5000/- was imposed upon vide orders dated 12.10.2020 and he was not designated as PIO on that day. He further intimates the Commission that Sh. Inderjit Singh was PIO when the RTI request was moved and penalty was imposed and presently he is posted as Assistant Town Planner in the office of Municipal Corporation, Bathinda.

Inderjit Singh, Assistant Town Planner office of Commissioner, Municipal Corporation, Bathinda, to ensure the compliance of the orders dated 12.10.2020 passed by the Commission, by depositing the penalty amount in the in the Treasury of Punjab Government .
