**ORDER**

The present appeal was earlier allocated to the Bench of Ld. State Information Commissioner, Shri Avtar Singh Kaler. However since the Ld. State Information Commissioner, Shri Avtar Singh Kaler has demitted his office on the completion of his tenure, the case has been re-allocated to the Bench of the undersigned vide Office Order dated 03.01.2022.

1. This Order may be read with reference to the Order dated 14.12.2021 passed by the Bench of Ld. State Information Commissioner, Shri Avtar Singh Kaler on the previous hearing.

2. Shri Balram, appellant comes present through CISCO Webex to attend the hearing and states that the PIO has not provided him the information regarding point no.2 of the RTI application.

3. The PIO, O/o Block Dev. & Panchayat Officer, Abohar has not come present to attend the hearing in person before the Bench or through CISCO Webex nor he has deputed any of his representative to attend the hearing. However the Commission has received a mail sent by the respondent, which is a copy of letter no.GOG/18/25/2019 dated 10.12.2021 alongwith a photocopy of duly signed receipt dated 08.09.2021 executed by Shri Balram, appellant.

4. As per letter no.GOG/18/25/2019 dated 10.12.2021 the respondent has given in writing that the information regarding point no.2 i.e. the photographs and videos of the site is not available in the record of the public authority.

5. After the perusal of the documents on record, it is found that the information regarding point no.2 of the RTI application is not available in the official record of the public authority, so the said information cannot be provided to the appellant.

6. In view of the above, **the present appeal case is disposed off and closed**. Copy of the order be sent to the parties. Copy of letter no.GOG/18/25/2019 dated 10.12.2021 sent by the respondent be sent to the appellant along with copy of the Order.
