

- 1. This order may be read with reference to the order dated 13.01.2021 passed by this Bench on the previous hearing.
- 2. The case has been heard today through V.C. in D.C. Office, Ludhiana. Shri Jasbir Singh, appellant comes present to attend the hearing through V.C. Post deliberations on the appeal case, the Bench observes that the information sought by the appellant is in the public interest and directs to the PIO to call the appellant to his office on 26.04.2021 at 11.30 AM and allow him access to the relevant official records. The appellant, after perusing the official records, will identify the information required by him and the information so identified, including the details of vacant properties, will be provided by the PIO to the appellant before the next hearing.

- 1. This order may be read with reference to the order dated 13.01.2021 passed by this Bench on the previous hearing.
- 2. The case has been heard today through V.C. in D.C. Office, Ludhiana. Shri Manjinder Singh, appellant comes present to attend the hearing in person before the Bench. He states that he has not received any information from the PIO.
- 3. Neither the PIO, O/o Secretary, R.T.A. Ludhiana has come present to attend the hearing through V.C. nor he has deputed any of his representatives to attend the hearing. Moreover, no information has been supplied to the appellant.

Rs.5,000/- (Rupees Five Thousand only) is imposed upon PIO, O/o Secretary, Regional Transport Authority, Ludhiana, to be deducted from his salary, which is to be deposited in the State Treasury under the relevant head. The Drawing & Disbursing Officer concerned is directed to deduct the amount of penalty of Rs.5,000/- from the salary of the PIO and deposit the same in State Treasury in the following Head of Account and to report its compliance to the Commission before the next hearing:-

- 1. This order may be read with reference to the order dated 13.01.2021 passed by this Bench on the previous hearing.

- 1. This order may be read with reference to the order dated 13.01.2021 passed by this Bench on the previous hearing.
- 2. The appeal case has been heard today through V.C. in DC Office, Ludhiana. Shri Amarjeet Singh Dhamotia comes present to attend the hearing through V.C. on behalf of the appellant. He states that no information has been received by the appellant.

The Drawing & Disbursing Officer concerned is directed to deduct the amount of penalty of Rs.5,000/- from the salary of the PIO and deposit the same in State Treasury in the following Head of Account and to report its compliance to the Commission before the next hearing:-

 - -0800-Other Receipts- 86-Fee under the RTI Act, 2005.
