4. After hearing the appellant and examining the case file , it is observed that today is the fifth hearing and incomplete information has been given to the appellant by the respondents.

5. It is, thus apparent from the response of the PIO that there has been delay in providing the information. Appellant had also suffered financial loss in getting the information. There are systemic deficiencies in the manner of receiving and disposing of applications.

The department still does not appear to be properly tuned to the performance of its obligations enshrined under the RTI Act. The departmental officials are not properly sensitized and trained to discharge their functions under the RTI Act 2005.

6. I am, therefore, of the view that the Appellant deserves to be awarded compensation under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him on account of delayed supply of information.

7. I am of the view that ends of justice would be met by awarding a sum of Rs. **5000/- (Rupees Five thousand only)** by way of compensation to the Appellant. This amount shall be payable by State Exchequer within fifteen days.

8. Further, the perusal of the file shows that during the last hearing BDPO, Khuiya Sarwar was directed to come present. But today again he not present. Even, he has neither filed his reply nor he has informed the Commission about his absence. Despite repeated directions, BDPO, Khuiya Sarwar is not appearing before the Commission **Hence, bailable warrant be issued to him through SSP, Fazilka so that he should appear before the Commission to present his case personally.**
