Gurwinder Singh Johal assures that the amount of compensation will be given to the Appellant on the next date of hearing.

State Information Commissioner, Prof. Viney Kapoor Mehra, penalty was imposed on Sh. Gurwinder Singh Johal, SDM Moga which was cancelled as Sh. Sukhkir Singh, Clerk who appeared after the hearing on the same date i.e. 19.12.2018, which was taken on record.

It is also observed that both the parties were absent on the previous hearing dated 19.06.2019 and today when the PIO is submitting the requisite information to the Appellant in the Court the Appellant, Sh. H.S. Hundal refuses to accept the same and further the Appellant is asking for imposing the penalty on the PIO. The penalty had earlier been imposed and waived off by Ld.
