ORDER

1. This order may be read with reference to the previous order dated 09.07.2019.
2. Respondent, Dr. K.P.S. Pasricha states that appellant had not supplied information relates with complaint to the respondent and reply along with rest of the information was supplied to the appellant dated 09.07.2019. He submits a reply vide letter no. 3876 dated 06.08.2019 signed by the Superintendent Grade-1-cum-PIO stating as follows:

ਜਦੋਂ ਕਿ ਪ੍ਰਾਰਥੀ ਵੱਲੋਂ ਸਿਕਾਇਤ ਦਾ ਨਿਪਟਾਰਾ ਕਰਨ ਬਾਰੇ ਉਸਨੂੰ ਪੰਜਾਬ ਸਿਵਲ ਸੇਵਾਵਾਂ ਰੂਲਜ਼ ਵਾਲੀਅਮ 1,2, ਅਤੇ 3 ਦੀ ਕਾਪੀ ਸੀ.ਡੀ.ਆਦਿ ਵਿੱਚ ਪਾ ਕੇ ਦੇਣ ਬਾਰੇ ਵਿਭਾਗ ਦੇ ਨੁਮਾਇੰਦੇਆ ਵੱਲੋਂ ਬੇਨਤੀ ਕੀਤੀ ਕਈ ਸੀ ਜਿਸ ਬਾਰੇ ਪ੍ਰਾਰਥੀ ਵੱਲੋਂ ਲਾਗੂ ਰੂਲਾਂ ਅਤੇ ਹਦਾਇਤਾਂ ਦੀ ਕਾਪੀ ਵਿੱਚ ਸਬੰਧਤ ਨਿਯਮ, ਸਬ ਨਿਯਮ ਆਦਿ ਦਾ ਹਵਾਲਾ ਦੇਣ ਬਾਰੇ ਸੂਚਿਤ ਕੀਤਾ ਗਿਆ ਸੀ।

ਪ੍ਰੰਤੂ ਪ੍ਰਾਰਥੀ ਵੱਲੋਂ ਇਸ ਸਬੰਧ ਵਿੱਚ ਸਪੱਸ਼ਟ ਨਹੀਂ ਕੀਤਾ ਗਿਆ ਕਿ ਉਸ ਵੱਲੋਂ ਕਿਸ ਕਿਸਮ ਦੀ ਸਿਕਾਇਤ ਦਾ ਜਿਕਰ ਕੀਤਾ ਗਿਆ ਹੈ ਕਿਉਂਕਿ ਸਿਕਾਇਤ ਦੀ ਕਿਸਮ, ਅਣਗਿਹਲੀ ਆਦਿ ਦੀ ਗੰਭੀਰਤਾ, ਸਬੰਧਤ ਅਣਗਿਹਲੀ ਕਾਰਨ ਹੋਏ ਨੁਕਸਾਨ ਆਦਿ ਦੇ ਮੱਦੇਨਜ਼ਰ ਹੀ ਸਬੰਧਤ ਰੂਲਾਂ ਆਦਿ ਦੀ ਰੋਸ਼ਨੀ ਵਿੱਚ ਸਮਰੱਥ ਅਥਾਰਟੀ ਵੱਲੋਂ ਕਾਰਵਾਈ ਕੀਤੀ ਜਾਂਦੀ ਹੈ। ਇਸ ਲਈ ਬੇਨਤੀ ਕੀਤੀ ਜਾਂਦੀ ਹੈ ਕਿ ਪ੍ਰਾਰਥੀ ਨੂੰ ਸਪੱਸ਼ਟ ਕਰਨ ਬਾਰੇ ਲੋੜੀਂਦੇ ਹੁਕਮ ਪਾਸ ਕੀਤੇ ਜਾਣ ਕਿ ਉਸ ਵੱਲੋਂ ਕਿਸ ਕੈਟਾਗਿਰੀ ਮਾਮਲੇ ਨਾਲ ਸਬੰਧਤ ਸਿਕਾਇਤ ਬਾਰੇ ਸੂਚਨਾ ਦੀ ਮੰਗ ਕੀਤੀ ਜਾ ਰਹੀ ਹੈ।

3. On this, appellant, Sh. Rajesh Gupta states that he is not satisfied with the supplied reply and information.
