**O R D E R**

Advocate Krishan Lal, appellant has filed RTI application dated 14.02.2019 and sought information from the PIO, O/o Police Commissioner, Ludhiana.

I have gone through the RTI application and discussed the matter with both the parties. The Respondent, ASI Jawala Parshad submitted a copy of letter no. 212 dated 05.08.2019. The appellant is seeking information regarding FIR No. 28 dated 27.01.2019 registered U/s 379 IPC at Police Station, Salem Tabri, Ludhiana. The Challan has already been presented under Section 173 of the Criminal Procedure Code before the Judicial Magistrate, Ist Class, Ludhiana in the month of June, 2019. The appellant has the copy of challan with him. The information has been provided to the appellant on 04.08.2019 and after receiving the information the appellant made a noting that the information is incomplete and he is not satisfied.

I have gone through the RTI application and discussed the sought for information with both the parties. The appellant brought some points before the Commission for which the information has not been provided. The appellant brought the fact that the information regarding point nos. 8 and 9 has not been provided, which is regarding certified copies of attendance register of ASI Jawala Parshad and HC Swaran Singh for the date 24.01.2019 and 27.01.2019. Secondly, the appellant brought to the notice of the Commission that case FIR No. 28 relates with the facts of Mobile No. 9888525251 for tracking CDR and IMEI No. 352929088536259, 352930088536257 which belongs to the appellant and the appellant is seeking the tracking report which was sought by the SHO from the Cyber Cell.

So, the PIO is directed that the information sought by the appellant regarding point no. 8 and 9 related the Attendance Register and the tracking report of above mentioned mobile number be provided to the appellant before the next date of hearing.
