2. On not receiving information from the PIO even after filing the First Appeal with the First Appellate Authority (hereinafter FAA) on 25.05.2021, the Appellant filed Second Appeal in the Commission on 01.10.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act) and as such Notice of hearing was issued to the parties.

3. The case has been heard today. The Appellant states that incomplete information has been provided to him whereas the Respondent states that requisite information has already been supplied to the appellant as available in the official records and today he files an Affidavit in this regard as under: -
