ORDER

1. The RTI application is dated 16.07.2019 whereby the information-seeker has sought information as mentioned in his RTI application. She filed complaint in the Commission on 31.07.2020 under Section 18 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice was issued to the parties for hearing for 06.10.2020 through CISCO WEBEX.
