1. ਮੈਂ ਅੰਗਰੇਜ਼ ਸਿੰਘ ਪੁੱਤਰ ਠਾਕੁਰ ਸਿੰਘ ਵਾਸੀ ਪਿੰਡ ਲੱਖੁਵਾਲ ਡਾਕਖਾਨਾ ਰਮਦਾਸ ਤਹਿਸੀਲ ਅਜਨਾਲਾ ਜ਼ਿਲ੍ਹਾ ਅੰਮ੍ਰਿਤਸਰ ਦਾ ਰਹਿਣ ਵਾਲਾ ਹਾਂ ਅਤੇ ਮੇਰਾ ਜ਼ੁਲ ਵਾਰਡਨ ਨੰਬਰ 219 ਹੈ। ਮੈਂ ਸਾਲ 1979-80 ਦੌਰਾਨ ਮਾਨਯੋਗ ਅਦਾਲਤ ਸ੍ਰੀ ਵਾਸੂ ਜੀ ਅੰਮ੍ਰਿਤਸਰ ਜੀ ਦੀ ਅਦਾਲਤ ਵਿੱਚ ਮਹਿਕਮੇ ਵਿੱਚ ਅੰਮ੍ਰਿਤਸਰ ਡਿਊਟੀ ਹਾਂਜਰ ਹੋਣ ਲਈ ਕੇਸ ਚਲਾਇਆ ਸੀ। ਜਿਸਤੇ ਕੇਂਦਰੀ ਜ਼ੁਲ ਗੁਮਟਾਲਾ ਦੇ ਕਲਰਕ ਵਲੋਂ ਹੀ ਮੇਰੀ ਸਰਵਿਸ ਬੁਕ ਅਦਾਲਤ ਵਿੱਚ ਪੇਸ਼ ਕੀਤੀ ਗਈ ਸੀ। ਜੋ ਕਿ ਮੇਰੀ ਰਿਕਾਰਡ ਮੁਤਾਬਕ ਸਰਵਿਸ ਬੁਕ ਹੁਣ ਵੀ ਅੰਮ੍ਰਿਤਸਰ ਜ਼ੁਲ ਦੇ ਰਿਕਾਰਡ ਵਿੱਚ ਦਰਜ ਹੈ। ਮੈਨੂੰ ਮੇਹਰਬਾਨੀ ਕਰਕੇ ਸਰਵਿਸ ਬੁਕ ਦੀਆਂ ਕਾਪੀਆਂ ਤਸਦੀਕ ਸੁਦਾ ਦਿੱਤੀਆਂ ਜਾਣ ਜੀ।

2. ਸਾਲ 1968 ਵਿੱਚ ਫਿਰੋਜ਼ਪੁਰ ਤੋਂ ਮੇਰੀ ਕੇਂਦਰੀ ਜ਼ੁਲ ਅੰਮ੍ਰਿਤਸਰ ਬਦਲੀ ਹੋਈ ਤੇ ਕੇਂਦਰੀ ਜ਼ੁਲ ਅੰਮ੍ਰਿਤਸਰ ਵਿੱਚ ਇੱਕ ਸਾਲ ਡਿਊਟੀ ਕੀਤੀ ਹੈ। ਉਸਦੇ ਰਿਕਾਰਡ ਦੀਆਂ ਤਸਦੀਕ ਸੁਦਾ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3.
