They submit that the information was attempted to be delivered at his residence but in vain. It was

refused to be accepted. Nonetheless they have brought along the certified copies which have been

arranged to be handed over on spot to the appellant. The appellant still expresses his dissatisfaction.

The Commission has considered the issue. A cursory glance on his application

suggests that he is seeking personal information of his erstwhile colleagues which certainly has no

connection with the public activity or interest. He is a retired government official who nurses some

grudges against some employees during the currency of his service. The RTI is not a forum to settle

personal scores. The information connected with the public activity like allotment of circles to the

Panchayat Secretaries has been delivered to him. The Commission feels that he has been suitably

informed and no further action is called for.
