3. Respondent, Sh. Charanjit Singh states that RTI application was received on 15.06.2018 and requisite information relates with point no. 1 and 4 was already been supplied to the appellant after collecting the documentation fee amounting Rs. 800/- (400 pages). He added that RTI application was transferred under Section 6(3) to the four (04) concerned respondent PIOs (Sh. Sandeep Singh Sandhu, Sh. Gaurav Kumar, Ms. Divya Goswami, Sh. Puneet Sharma) dated 20.06.2018 to supply the information relates with point no. 2 and 3.

He submits a reply to the Show Cause notice dated 07.10.2019 along with supporting documents stating the same as per the above para no. 3, which is taken on record.

4. Respondent, Ms. Divya Goswami states that she has supplied the requisite information in connection with point no. 2 and 3 comprising 3384 pages after collecting the documentation fee Rs. 6768/- from the appellant.

She submits a reply dated 07.10.2019 along with supporting documents stating that rest of the partial information in connection with point no. 2 and 3 relates with respondent PIOs, Sh. Sandeep Kumar Sandhu and Sh. Gaurav Kumar.

5. Respondent, Sh. Sandeep Singh Sandhu states that record is not available in the official record as it was already deposited to the department. He added that clerk has given in writing that no record is available.

6. On this, respondent, Sh. Ravinder Garg states that due to frequently changed clerks in the department no proper record has been maintained.

7. After hearing both the parties and examining the case file, respondent, Sh. Ravinder Garg, is O/o Civil Surgeon Sangrur (FAA) is directed to look into the matter and supply the compensation cheque amounting Rs. 1,500/- to the appellant from the account of Public Authority (O/o Food Safety Officer, Sangrur) and not from the individual's account. He is also directed to submit a copy of said cheque/DD to the Commission by the next date of hearing.

He is also directed to supply the reply which is pending from the respondent PIOs, Sh. Sandeep Singh Sandhu and Sh. Gaurav Kumar to the appellant before the next date of hearing.

8. First Appellate Authority, Respondent PIO, O/o Civil Surgeon, Sangrur is directed to make sure that RTI applications are dealt in time and hear cases at their level to make the appellant satisfied when appellant filed first appeal.

9. A copy of this order be sent to the respondent PIOs, Sh. Charanjit Singh, Sh. Sandeep Singh Sandhu, Sh. Gaurav Kumar, Ms. Divya Goswami, Sh. Puneet Sharma and Sh. Ravinder Garg through **registered post** for their ready reference.

ORDER

1. This order may be read with reference to the previous order dated 02.09.2019.
2. Appellant, Sh. Jasbir Singh is not present for today's hearing but an email dated 06.10.2019 has been received from the appellant by the bench of undersigned stating that compensation cheque is still pending from the respondent PIO.
3. Respondent, Sh. Abhinav Kumar requested to waive off the penalty. He added that appellant sought information through RTI application dated 01.06.2018 and information was ready to send dated 22.06.2018 but inadvertently wrong information was sent to the appellant while dispatching.

He submits a reply dated 07.10.2019 along with Annexure 1 stating that the undersigned has multifarious duties which has to attend sometimes on a very short notice such as Tandrust Punjab Mission and Checking/Inspection of Food Consumables as per the Order of the CMO/Deputy Commissioner. In that reply he added that appellant is satisfied with the information supplied and requested to waive off penalty amounting Rs. 10,000/-.

4. After examining the case file, it is observed that an email dated 04.10.2019 has been received from the email ID civilsurgeonmoga1@gmail.com comprising copies of letter numbers 12775-80 dated 03.10.2019, 12858 dated 04.10.2019 along with copy of an acknowledgement letter signed by the appellant dated 14.09.2019 stating that information relates with point no. 1 to 4 has been received and he is satisfied with the supplied information.

5. After hearing the respondent and examining the case file, I am of the considered view that submitted reply as per para 3 of this order is satisfactory and penalty which was imposed on the concerned respondent PIO, Sh. Abhinav Kumar is waived off as he genuinely dealt this case within time period. He is advised to be careful in future while dealing the RTI applications.

It is found that appellant; Sh. Jasbir Singh is satisfied with the supplied information and now this case is only pending for the compliance of order of the Commission regarding the Compensation amounting Rs. 2,000/- which was awarded to the appellant vide order dated 28.05.2019

6. Respondent PIO, Sh. Jitender Virk, O/o FSO, Moga is directed to supply the compensation cheque amounting Rs. 2,000/- to the appellant from the account of Public Authority (O/o Food Safety Officer, Moga and not from the individual's account. He is also directed to submit a copy of said cheque/DD to the Commission by the next date of hearing positively. A copy of this order be sent to him through **registered post.**
