After examining both the parties and examining the case file, it is observed that satisfactory reply and information has been supplied to the appellant as per RTI application and appellant is advised to file a fresh RTI application in connection with point no. 6 as requisite information relates with this point is voluminous in nature and not compiled at one place.

5. As appellant pointed out regarding his letter and email was not taken on record in the previous Order of the Commission dated 02.12.2019. Following observations are made:

- In letter dated 21.10.2019 which was received in the Commission vide diary no. 20304 dated 21.10.2019, nothing is mentioned regarding the hearing 02.12.2019. This letter received with the Subject: A/C-1256/2019 slated for hearing on 11/11/2019. Appellant

submitted today this same letter with an addition of dated 02.12.2019 below the 11/11/2019.

- Email dated 29.11.2019, which was sent on the email ID psic25c@punjabmail.gov.in instead of psic25@punjabmail.gov.in so this email was not received by the bench of undersigned.

6. In wake of above, no cause of action is left in this case. Hence, the instant appeal case is **disposed of & closed.**
