ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 08.11.2018. First appeal is dated 19.12.2018. Second appeal has been received in the Commission on 03.04.2019.

On the last date of hearing, held on 13.12.2021 ;

- i) Neither the appellant nor the respondent was present.
- ii) The respondent PIO through a reply vide letter no. 24250 dated 28.09.2021 signed by PIO office of State Transport Commissioner, Punjab, Chandigarh, had intimated the Commission that pension of the concerned PIO (who is Sh. Gurcharan Singh Sandhu, the then PIO-cum-Secretary (Retd.), Regional Transport Authority, Sangrur) is not approved and whenever his pension would be released, deduction of penalty amount of Rs. 5000/- (which was imposed vide order dated 18.09.2019) would be made.
- iii) Last opportunity was given to the respondent PIO concerned to comply with the order dated 18.09.2019 passed by the Commission by paying penalty of Rs. 5,000/- in the Treasury of Punjab Government and a copy of challan receipt be sent to the Commission.

The appellant, Sh. Shakti Bhushan, who appeared in person in today's hearing, states that he has received the required information in the instant appeal-case.

Ms. Kulwinder Kaur, Superintendent-cum-PIO office of State Transport Commissioner, Punjab, Chandigarh, who appeared in person in today's hearing, states that regular pension of the concerned PIO (who is Sh. Gurcharan Singh Sandhu, the then PIO-cum-Secretary (Retd.), Regional Transport Authority, Sangrur) has not been approved, moreover, case for issuance of his provincial pension is also pending.
