The PIO Shri Akashdeep Singh Aulakh states that with regard to the information sought by the appellant, on the basis of enquiry into complaint No.29/18-Faridkot, vigilance enquiry NO.07 dated 07.08.2020-Bathinda was got conducted

by SSP Vigilance Bureau, Ferozepur through DSP Vigilance Bureau, Unit Sri Muktsar Sahib. The enquiry report submitted in this regard was considered at Head Office in all aspects legally and on the basis of enquiry report, FIR No.12 dated 18.10.2021 has been registered at Police Station, Vigilance Bureau, Ferozepur. The investigation into this case is pending with SSP Vigilance Bureau, Ferozepur. He further states that challan against four persons involved has been presented in the Ld. Court, whereas challan against other nine persons has still to be presented in the Court. He states that at present, only a copy of FIR can be given to the appellant as dissemination of other related documents will affect the proceeding of the case and its outcome.

4. Post deliberations and upon hearing the version of the PIO, the Bench directs the PIO O/o Chief Director, Vigilance Bureau, Punjab, Mohali to file an affidavit, within 21 (twenty one) days, on non judicial stamp paper, duly signed by the PIO, incorporating therein the position as stated by the PIO before the Bench. It be further stated that nothing has been concealed therein and the statement made is true and correct. The original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

5. With the aforesaid directions, **the instant appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
