ORDER (First hearing):

The Appellant/Complainant filed above mentioned appeal/complaint cases in the Commission dated 11.11.2021. Accordingly, the cases are fixed for today.

Observation & Decision:

On perusal of the RTI application it is noted that the appellant had himself submitted a vague and ambiguous query with regard to the points mentioned in the RTI application.

Under Section 6(1) of the RTI Act very clearly states that the **information** seeker has to specify the particulars of the **information** sought by him or her". **In view of these observations**, the PIO is directed to offer inspection of the relevant available records to the appellant at a mutually convenient date and time. The appellant is directed to avail of the said offer and ask specific required information, failing which no further opportunity will be provided to him. The Commission in this context, also directed the appellant to deposit the necessary fee for Xeroxing the documents [@Rs2 per copy] in accordance with the provision of Right to Information (Regulation of fee and costs) Rules, 2005 so that the desired documents may be provided to you under RTI Act, 2005.

This titled case of the appellant is **remanded to the First Appellate Authority O/o Superintending Engineer, Construction Division, Amritsar** and is directed to treat this application of the appellant as first appeal and decide the same within the period prescribed under the provisions of the RTI Act, 2005. He is also directed to pass an appropriate order after hearing both the parties and as per the order of the commission. A Compliance report shall be submitted by the Respondent before the Commission within 45 from issue of this order.

With these directions the case is disposed of and closed
