#### ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 29.10.2019. First appeal is dated 02.12.2019. Second appeal has been received in the Commission on 21.01.2020.

On the last date of hearing, held on 06.01.2021, Sh. Rohit Kumar, Clerk, Zone-B, stated that complete information was supplied to the appellant and he has given signatures as an acknowledgement receipt. The appellant stated he had given acknowledgement only on the assurance of the respondent that the identified information would be sent to him but till date required information not received. Accordingly, the respondent PIO concerned was directed to send the requisite information again to the appellant through registered post with a copy to the Commission .

The appellant, Sh. Gurmej Lal, who appeared in person in today's hearing, states that still incomplete information has been given to him.

Since complete information has been again sent by the respondent PIO to the appellant in the instant appeal case and no cause of action is left in this case, hence, the show-cause issued to the concerned respondent PIO vide orders dated 09.06.2020 is dropped and the case is announced as disposed of and closed.
