Yashvir Mahajan directed the President of the Bar Association to provide the information to the appellant and on not receiving the requisite information from the respondent PIO, appellant approached the Commission and a letter number 138 dated 06.03.2020 was sent to the President, Bar Association, Fatehgarh Sahib by the Commission to supply the information within 15 fifteen days from the receipt of that letter but the President shows irresponsible behavior towards the Orders of the Commission and not supplied information to the appellant.

3. On this, appellant, Sh. Subhash Chandra Basu states that information in connection with point no. 1 and 7 is still pending from the respondent PIO.
4. After hearing both the parties and examining the documents placed on record, respondent PIO is directed to supply the reply/information in connection with point no. 1 and 7 to the appellant by the next date of hearing positively under the intimation to the Commission. Both the parties to represent this case in person on the next date of hearing positively, failing to which case will be decided on merit basis.
