

managed to procure admission in the various DIETs by producing counterfeit S.C. certificates and thereafter, got the Government job in the general category.

Shri Lakhwant Singh, Incharge Principal, DIET Sri Muktsar Sahib who is present, submits that the certificates purported to have been produced by them are not available in the record. However, the register in which the entries of their categories at the time of admission were made is available, certified copy of which has already been provided to the information seeker.

The respondent O/o DEO (Ele.Edu.), Fazilka has produced an affidavit deposing therein that they have already provided copies of entire record available with them.

The appellant is absent, he has sent a communication that the information in case in hand, has been provided to him to his satisfaction. The Commission does not intend to further intervene in the matter.
