Decision.

That the information stands provided to the best possible extent.

That since it is a complaint case I am more inclined to look into the conduct of the PIO in handling this RTI Application.

That there has been a delay of more than five months in providing the information.

That the Commission has taken a serious view of this and hereby directs the PIO to show cause why penalty be not imposed on him under Section 20 of the RTI Act 2005 for not supplying the information within the statutorily prescribed period of time. He/she should file an affidavit in this regard. If there are other persons responsible for the delay in providing the information, the PIO is directed to inform such persons of the show cause and direct them to appear before the Commission along with the written replies.

The appellant through RTI application dated 23.10.2019 has sought information regarding status of action taken on the application dated 15.10.2019 relating to cancellation of rapat dated 13.06.2011 and mutation no.69186 & 23095 as per decision of SDM Moga and other information concerning the office of SDM Moga. Having gone through the record, it was found that the appellant had earlier filed a similar appeal case for seeking exactly the same information which was disposed off by the ld bench of Dr.Pawan Kumar Singla on 23.06.2020 whereas in the certificate submitted to the Commission, the appellant has certified that no appeal or complaint has earlier been filed, pending or decided by any of the State Information Commissioner.

The appellant was directed to personally appear before the Commission on the next date of hearing and plead his case.

On the date of hearing on **28.01.2021**, the appellant informed that as per order/decision of First Appellate Authority-cum-SDM Moga, the information provided by Patwari Halka Mahil Singh-II is incomplete till the information from Patwari Halka Moga Mahil Singh-1 is provided.

The Commission also received a letter from the appellant on 21.01.2021 which was taken on the file of the Commission.

ORDER:

The appellant through RTI application dated 11.09.2019 has sought information regarding ownership of bir on the both sides of main road from Bhagta to Barnala road before coming into jurisdiction of Forest Department – year of including into forest department – total land in name of Sohan Singh and Sahib singh and other information concerning the office of DC Moga. The appellant was not provided the information after which the appellant filed first appeal before the first appellate authority on 16.03.2020 which took no decision on the appeal.

The case was first heard on 06.10.2020. The respondent present pleaded that as per report collected from the Naib Tehsildar Sambalpur, the information that has been sought by the i.e. jamabandi of the land relating to Sohan Singh s/o Kasuria Singh of village Dayalpura Bhaika Tehsil Rampurapul, relates to Tehsil Rampura Phul, District Bathinda.

The PIO however, did not transfer the RTI application to the concerned PIO. As per appellant, the RTI application was filed to Director Land Records, Jalandhar and since the information was not provided, the appellant filed first appeal before the First Appellate Authority which transferred the same to First appellate Authority-DC Moga and the DC Moga further transferred the RTI application to Tehsildar Baghapurana but the Tehsildar Baghapurana has not transferred it to the concerned PIO.

The Tehsil Office Baghapurana in spite of identifying and transferring the RTI application to the concerned public authority, would possibly hold this information and got the signature of the appellant asking him to state that this information does not pertain to them but pertains to Rampuraphul, District Bathinda. The Commission had taken a very serious view of this anomaly of the PIO which is not in accordance with the RTI Act and trying to coax the appellant to write that the information does not pertain to this office.

Appeal Case No. 1683 of 2020

The PIO-Tehsildar Baghapurana was directed to explain the reasons for holding the information and not identifying and transferring the RTI application to the concerned public authority within the time prescribed under the RTIAct.

The appellant pleaded that this information lies with the Director of Land Records Jalandhar. The Commission accepted the plea of the appellant and impleaded the PIO-Land Records, Jalandhar the original office where the appellant had filed RTI application and directed the PIO-Director Land Records to provide the information and if the information does not exist, to identify the correct public authority and transfer the same to that particular authority.

On the date of last hearing on 28.01.2021, as per respondent, the information did not pertain to them and they had already replied to the appellant.

The Commission also received a letter from the PIO-cum-Tehsildar Baghapura stating that as per report of Naib Tehsildar Samalpur, the information that has been sought by the appellant relates to village Dayalpura under Tehsil Rampura Phul, Bathinda.

As per appellant, the information lies with the Director of Land Records, Jalandhar. The PIO-Land Records was absent.

The PIO-Director of Land Records, Jalandhar was given one more opportunity to look at the RTI application(a copy of which was attached with the order) and provide the information to the appellant. The PIO-Land Record was also directed to appear on the next date of hearing and explain the reasons for not complying with the order of the Commission.

Hearing dated 07.05.2021:

The case has come up for hearing today through video conferencing at DAC Moga. Sh.Amarjit Singh, Suptd. present from the office of Director Land Record informed that since the information that has been sought by the appellant relates to village Dayalpura under Tehsil Rampura Phul, Bhatinda and Forest Department, the RTI application has been transferred to them vide letter dated 16.03.2021. The Commission has also received reply of the PIO-Director Land Record on 23.03.2021 which has been taken on the file of the Commission.

The PIO-Punjab State Forest Development Corporation Ltd. Mohali and PIO-Tehsildar Rampuraphul are impleaded in the case and directed to look at the RTI application transferred by Director Land Records on 16.03.2021 and provide information to the appellant as per the RTI Act. A copy of RTI application is being attached with the order for the benefit of both PIOs.

ORDER: This case should be read in continuation to the earlier order.

On the date of hearing of 30.07.2019, Sh.Prince Kumar, Clerk O/o SDM Moga appeared and pleaded that the information regarding point-1 relates to them and they have already sent reply to the appellant that the information is 3rd party information, it cannot be provided. The information regarding points-2 & 8 relates to Tehsildar Moga and remaining information relates to PWD(B&R) Moga. The respondent further pleaded that the information has also been provided to the appellant by the PIO-PWD and PIO-Tehsildar concerning them.

Having gone through the record, and hearing both the parties, the following was concluded:

Point-1, 5, 6 & 7 - The information pertains to 3rd party. The concerned 3rd parties

are impleaded in the case and directed to appear before the

commission and plead why their information be not provided.

Point-2 & 8 - Relates to Tehsildar Moga. The Tehsildar Moga is directed to

provide the information as per RTI application

Point-3 - PIO-SDM Moga to procure from PIO-PWD and send to the

appellant.

The appellant was also directed to file written submission to establish in writing that the disclosure of information has a larger public interest as he had made allegation of corruption while disbursing money.

On the date of hearing on **19.12.2019**, the respondent present from the office of SDM-Moga informed that the information regarding point-3 has been sent to the appellant vide letter dated 06.11.2019 and a copy of the same is submitted to the Commission. The PIO-Tehsildar, Moga and both the 3rd parties were absent. The appellant was absent and vide email had submitted his written submission which was taken on the file of the Commission.

The PIO-Tehsildar, Moga was given one last opportunity to comply with the earlier order of the Commission and provide the information on Points-2 & 8. The PIO was also directed to be present on the next date of hearing. Both the 3rd parties were also given one last opportunity to appear before the Commission and plead their case.

Appeal Case No. 3615 of 2018

On the next date of hearing on **24.02.2020**, the appellant was absent and vide email has informed that he has not received the information regarding point-3 from the office of SDM Moga as recorded in the last order. The appellant further informed that he has not received information on other points also. A copy of the information regarding point-3 submitted by the respondent at the hearing on 19.12.2019 was attached with the order for the appellant.

The PIO-SDM Moga was absent. The PIO-Tehsildar Moga was also absent and vide email has sought adjournment on the plea that they have been deputed by the SDM to attend Mahatma Gandhi Sarbat Vikas Yojna camp to be organized on 24.02.2020 at Ghal Kalan.

Sh.Gurmukh Singh, the 3rd party was present and pleaded that his file relating to his assessment be not provided. The case was adjourned.

On the date of hearing on **07.07.2020**, the respondent present from the office of SDM pleaded that the information regarding point-3 has already been provided. The appellant was absent and vide email has informed that he has received the information on point-3 but the information on points-2 & 8 has not been supplied.

The PIO-Tehsildar Moga was absent. The respondent present from the office of Tehsildar Moga sought some more time and assured to supply the information on points-2 & 8 within 10 days. The PIO-Tehsildar Moga was directed to supply the information on points-2 & 8 within 10 days and send a compliance report to the Commission.

On the date of last hearing on **01.09.2020**, both the parties were absent. The appellant vide email has informed that the discrepancies in the information has been pointed out to the PIO O/o Tehsildar Moga vide email dated 16.07.2020 with a copy to the Commission. The appellant has further informed that he contacted Mr.Mangaljit Singh, Reader to the Tehsildar Moga who informed that the entire staff had been on strike and had requested for some more time to provide the information. The appellant stated that he has no objection if the Hon'ble Court grants additional time to the PIO to provide the complete point-wise information.

The PIO was directed to sort out the discrepancies as pointed out by the appellant via email dated 16.07.2020.

On the date of last hearing on 28.01.2021, as per respondent, the discrepancies as pointed out by the appellant had been sorted out and the information had been provided to the appellant on 22.11.2020. As per appellant, no information was provided by the PIO on points 2 & 8 despite his many visits to the office of the PIO.

The PIO was given one last opportunity to sort out the discrepancies as pointed out by the appellant and send the complete information on points 2 & 8 to the appellant through registered post with a copy to the Commission within 10 days of the receipt of the order.

Hearing dated 07.05.2021:

The case has come up for hearing today through video conferencing at DAC Moga. The appellant is via a mobile phone and informed the PIO has not provided the information regarding points 2 & 8. The Commission has also received an email from the appellant in this regard which has been taken on the file of the Commission.

The respondent present from the office of SDM Moga informed that the information has to be provided by Tehsildar Moga. The respondent present from the office of Tehsildar Moga is present.

Appeal Case No. 3615 of 2018

The PIO is given one last opportunity to send information relating to point 2 & 8 in a sealed envelope to the Commission. The information should reach the Commission by Friday the 14th May, 2020.

The appellant may collect the information from the office of the Commission.

To come up for further hearing on **10.08.2021 at 11.00 AM** through video conference facility available in the office of Deputy Commissioner, **Moga.** The appellant to appear through VC at DAC Mohali.
