## ORDER:

The appellant through RTI application dated 26.06.2020 has sought information regarding final decision taken by Tehsildar Moga on the enquiry report sent by Kanoongo Halka Mehal Singh on 05.12.2019 relating to the enquiry on the application of the appellant dated 27.08.2019 and other information as enumerated in the RTI application concerning the office of Tehsildar Moga. The appellant was not provided with the information after which the appellant filed first appeal before the First Appellate Authority on 23.07.2020 which disposed off the appeal on 04.09.2020.

The case was first heard on 03.03.2021. The respondent present pleaded that the available information has been provided to the appellant and no other information is available.

The appellant was absent and vide letter received in the Commission on 16.02.2021 informed that the information provided by the PIO vide letter dated 07.07.2020 is incomplete since the information regarding decision taken by the Tehsildar Moga on the report No.454 dated 05.12.2019 of Kanoongo Halka Mehal Singh, has not been provided to the appellant.

Having gone through the RTI application and hearing the respondent, the Commission directed the appellant to inspect the record by visiting the office of the PIO on any working day by fixing a mutually convenient date and time and get the relevant information. The respondent was directed to allow inspection of the complete record to the appellant pertaining to this RTI application and if there is any further document available, it be provided.

## Hearing dated 07.05.2021:

The case has come up for hearing today through video conferencing at DAC Moga. The appellant is absent. The appellant has sent a letter regarding inspection of the record along with a document. The mentioned document is signed by the Tehsildar and the appellant whereby the Tehsildar has ordered to provide copies of action taken by the field staff to the appellant.

To comply with the order of the Tehsildar, the field staff has provided the photo copies of action taken report No.384/1 dated 13.11.2019 and report No.176 dated 07.11.20219 to the appellant and the appellant has received the same.

The information stands provided. No further course of action is required. The case is disposed of and closed.
