On the recommendation of Ethical and Disciplinary committee-B dated 02.12.2020 Dr. Jagjivan Singh was called to attend the next Ethical and Disciplinary committee-B meeting. Dr. Jagjivan Singh has appeared before the Ethical & Disciplinary committee on 10.02.2021 and submitted the statement.

The Disciplinary/ Ethical committee-B recommended on 10.02.2021 that:-

"The complainant is old age and his wife has not wear helmet. On-going through the medical record and statements of Dr. Jashneev Kapoor and Dr. Jagjivan Singh, Anaesthetist, Dr. Jagjivan Singh has given Regional Anaesthesia as per protocol and managed the complications of anaesthesia by adopted proper procedure. The committee is of the opinion that no medical negligence on the part of treating doctors, so the case be filed and closed".

The above recommendations has also approved in the General Body meeting of Punjab Medical Council on 24.02.2021.
