



The PIO also states that a letter dated 03.07.2020 has also been sent to the appellant stating that he has not given any specific detail of information sought and the information sought is voluminous and as such, specific date and month & year are required by the PIO to furnish this information.
- 4. After discussions with the parties, it is decided that PIO will again call the appellant to his office to allow him to inspect the relevant record and to identify specifically the

documents/information required by him. The PIO will supply the copies of documents/information so identified by the appellant before next date of hearing.


