ORDER: This case should be read in continuation to the earlier order.

On the date of hearing of 30.07.2019, Sh.Prince Kumar, Clerk O/o SDM Moga appeared and pleaded that the information regarding point-1 relates to them and they have already sent reply to the appellant that the information is 3rd party information, it cannot be provided. The information regarding points-2 & 8 relates to Tehsildar Moga and remaining information relates to PWD(B&R) Moga. The respondent further pleaded that the information has also been provided to the appellant by the PIO-PWD and PIO-Tehsildar concerning them.

Having gone through the record, and hearing both the parties, the following was concluded:

- Point-1, 5, 6 & 7 - The information pertains to 3rd party. The concerned 3rd parties are impleaded in the case and directed to appear before the commission and plead why their information be not provided.
- Point-2 & 8 - Relates to Tehsildar Moga. The Tehsildar Moga is directed to provide the information as per RTI application
- Point-3 - PIO-SDM Moga to procure from PIO-PWD and send to the appellant.

The appellant was also directed to file written submission to establish in writing that the disclosure of information has a larger public interest as he had made allegation of corruption while disbursing money.

On the date of hearing on **19.12.2019**, the respondent present from the office of SDM-Moga informed that the information regarding point-3 has been sent to the appellant vide letter dated 06.11.2019 and a copy of the same is submitted to the Commission. The PIO-Tehsildar, Moga and both the 3rd parties were absent. The appellant was absent and vide email had submitted his written submission which was taken on the file of the Commission.

Appeal Case No. 3615 of 2018

The PIO-Tehsildar, Moga was given one last opportunity to comply with the earlier order of the Commission and provide the information on Points-2 & 8. The PIO was also directed to be present on the next date of hearing. Both the 3rd parties were also given one last opportunity to appear before the Commission and plead their case otherwise it will be presumed that they have nothing to say in the matter and the case will be decided on merits.

On the last date of hearing which was held on **24.02.2020**, the appellant was absent and vide email has informed that he has not received the information regarding point-3 from the office of SDM Moga as recorded in the last order. The appellant further informed that he has not received information on other points also. A copy of the information regarding point-3 submitted by the respondent at the hearing on 19.12.2019 was attached with the order for the appellant.

The PIO-SDM Moga was absent. The PIO-Tehsildar Moga was also absent and vide email has sought adjournment on the plea that they have been deputed by the SDM to attend Mahatma Gandhi Sarbat Vikas Yojna camp to be organized on 24.02.2020 at Ghal Kalan.

Sh.Gurmukh Singh, the 3rd party was present and pleaded that his file relating to his assessment be not provided. The case was adjourned.

The case has come up for hearing today through video conferencing at DAC Moga. The respondent present from the office of SDM pleaded that the information regarding point-3 has already been provided. The appellant is absent and vide email has informed that he has received the information on point-3 but the information on points-2 & 8 has not been supplied.

The PIO-Tehsildar Moga is absent. The respondent present from the office of Tehsildar Moga has sought some more time and assured to supply the information on points-2 & 8 within 10 days.

The PIO-Tehsildar Moga is directed to supply the information on points-2 & 8 within 10 days and send a compliance report to the Commission.

ORDER:

The appellant was denied the information by the PIO vide letter dated 16.09.2019 stating that the information sought is personal information of Sh.Bhag Singh and Sh.Bhag Singh has not given his consent to disclose the information, after which the appellant filed first appeal before the First Appellate Authority on 04.10.2019 which disposed off the appeal on 17.10.2019.

Order:

This order be read in continuation to the earlier order.

On the date of hearing of **26.03.2019**, the respondent present pleaded that the information sought by the appellant is not specific and is third party information. After having gone through the arguments of the case, the Commission found the pleas of the PIO untenable. The Commission observed that since the appellant being a co-parcener and legal heir in the property, has every right to access the information. The PIO was directed to provide the information to the appellant as sought in the RTI application before the next date of hearing.

On the next date of hearing on **24.04.2019**. The respondent present brought the Vasika numbers and informed that on the basis of these vasika numbers, the appellant can get the information from the Sewa Kendra by depositing requisite fee. The appellant said that since they have asked the information under RTI Act, they are not to go to the Sewa Kendra and the information be provided under the RTI Act. The respondent was directed to raise the fee under the RTI Act within a week and provide the information before the next date of hearing.

On the date of hearing on **19.12.2019**, the respondent brought partial information (Vasika Nos.5617, 5619 & 3434) which was taken on the file of the Commission. The appellant was asked to come to the Commission any time and collect the same. The respondent however, pleaded that two vasika Nos 55 & 761 are not registered and these numbers can be wrong. The respondent further pleaded that the remaining vasika nos 09, 639, 649, 6436 & 04 would be provided to the appellant within 15 days after getting these attested from the competent authority. The PIO was directed to send certified copies of the remaining information to the appellant within 10 days through registered post.

On the last date of hearing on **25.02.2020**, the respondent brought remaining vasika Nos. 09, 639, 649, 6436 & 04 which were taken on the file of the Commission. The appellant was absent. The appellant was directed to collect the same from the office of the Commission.

The appellant appeared late and collected all the vasika submitted by the respondent. The appellant however, pointed out some discrepancy in the information.

Appeal Case No. 3838 of 2018

Hearing dated 07.07.2020:

The case has come up for hearing today through video conferencing at DAC Fazilka. The respondent present pleaded that the information available in the record has been provided to the appellant. The appellant is not satisfied. The Commission has received observations of the appellant which has been taken on the file of the Commission.

Hearing both the parties, the PIO is directed to bring entire record to the Commission at the next date of hearing. A copy of the observations is being attached with the order for the PIO. The appellant is directed to appear personally on the next date of hearing to plead his case.

The case is adjourned. To come up for further hearing on **10.08.2020 at 11.00 AM.**
