He further states that as per RTI application, there are two main grievances of the appellant i.e. installation of lights in the colony as well as construction of pucca street. The appellant has, accordingly, been asked to file an application in this regard for consideration.

4. The Bench apprises the appellant of the version of representative of PIO and clarifies that the information stands provided. The issues related to execution of a work on installation of lights and construction of pucca street is not in the domain of Information Commission.

5. In view of the above, the Bench feels that no further intervention in the matter is needed. **The appeal case is disposed off and closed.** Copies of the order be sent to the concerned parties.
