He also states that as the matter relates to MC, Sri Muktsar Sahib, Executive Officer-cum-PIO, has supplied original affidavit to the complainant by registered post on 23.06.2022.

4. The complainant confirms the receipt of original affidavit filed by the PIO, Sri Muktsar Sahib, the Bench finds that no further cause of action is left. Hence, the **case is disposed off and closed**. Copies of the order be sent to the concerned parties.

The PIO is directed to send original affidavit to appellant and e.mail copy of the same to Bench.
