Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 08.07.2019. First appeal is dated 08.08.2019.

Second appeal has been received in the Commission on 26.11.2019.

On the earlier hearing, held on 18.02.2020, the respondent PIO concerned was directed to facilitate the appellant to inspect relevant official record on 12.03.2020 at 11:00 A. M. to identify the information with the directions to supply the required information, which would be identified by the appellant, to him.
