But in the interest of justice a last and final opportunity is granted to Shri Charanjit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Laduka to send the attested copies of sought for information along with the demand draft of Rs.2,000/- as compensation to the appellant through registered post within 10 days and compliance be sent to the Commission.

The PIO-cum-Panchayat Secretary is further directed to file reply to the Show Cause Notice in writing and send the same to the Commission within 10 days and an opportunity of personal hearing will be afforded to him on the Show Cause Notice. In case the PIO would not comply with the Order of the Commission and would not send reply to the Show Cause Notice, then it will be assumed that he do not want to say anything in his defence and the Show Cause Notice will be decided on the next date of hearing without hearing him and he will be penalized up to Rs.25,000/-, which will be deducted from his salary.

Both the parties should connect through **CISCO WEBEX MEETINGS Software(Meeting No. 1582695783)** on the next date of hearing i.e. **30.09.2021 at 11:30 A.M.**

A copy of the Order be sent to the DDPO, Fazilka and BDPO, Jalalabad through registered post for strict compliance of the Order of the Commission.
