**ORDER**

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 30.01.2018. First appeal is dated 06.03.2018.

Second appeal has been received in the Commission on 11.07.2018

On the last date of hearing, held on 29.07.2020, the appellant intimated the Commission that after the inspection samples of the material was collected but not handed over to him by the respondent PIO till date. Sh. Ranvir Singh, Executive Officer, intimated the Commission that in the instant appeal case, responsibility of Sh. Kulwinder Singh, Municipal Engineer was fixed to provide samples of the material to the appellant. Accordingly, last and final opportunity was given to Sh. Kulwinder Singh, Municipal Engineer (whose responsibility was fixed for supplying of samples of the material as per version of Sh. Ranvir Singh, Executive Officer) to provide certified samples of the material to the appellant and seal the same to the appellant well in time and send forwarding letter of the same with acknowledgement receipt signed by the appellant to the Commission. An opportunity was also given to the appellant to intimate the Commission. A show cause notice under Section 20 (1) of the RTI Act was issued to Sh. Kulwinder Singh, Municipal Engineer (whose responsibility was fixed for supplying of samples of the material) office of Executive Officer, Nagar Council, Khanna, under the provisions of the RTI Act, 2005.

The appellant, Sh. Ramandeep Singh Ahluwalia , who appeared in person in today's hearing, orally states that he has received the requisite information.

Sh. Kulwinder Singh, Municipal Engineer, who appeared in today's hearing with Sh. Gurdarshan Singh, Superintendent, states that the required information has been given to the appellant vide letter no. 2142-2144 dated 05.10.2020. On that reply, the appellant has put his signatures on 05.10.2020 as an acknowledgement receipt. He also intimates the Commission that he has sent a reply to the show-cause, issued to him vide orders dated 29.07.2020 vide letter no. 2147 dated 05.10.2020. It, alongwith annexure, is taken on record.

Since the information stands supplied and the appellant has given his consent to close the case, the show-cause issued to the concerned respondent PIO is **dropped** and the case is announced as **disposed of and closed**.
