**ORDER:**

The appellant through RTI application dated 18.12.2019 has sought information regarding list of teachers of St.Peter's Convent High School, Naraingarh Chheharta – salary last drawn – medical allowance of teacher – residential address of teachers – parents'/husband's name of teachers and other information concerning the office of DEO(Primary) Amritsar. The appellant was not satisfied with the reply of the PIO dated 20.01.2020 after which the appellant filed first appeal before the first appellate authority on 30.10.2020 which took no decision on the appeal.

I have looked at the RTI application and appeal and it is clear that the information that the appellant has sought is of a private school, which is not a public authority. It means that the information that the appellant is seeking isn't held by the education department, the public authority which regulates schools. However, the respondent informs us that the information is available on a specific website where information about all teachers is uploaded, and the address of the website has already been provided to the applicant.

Given the above, I see no further cause of action in this case and is **disposed off**.

The appellant through RTI application dated 06.01.2020 has sought information regarding works undertaken during 06.01.2019 to 06.01.2020 in Sub Division Ajnala, Chogawan, Majitha, Sub Division No.5 Amritsar – work order – comparative statements and other information concerning the office of Xen Water Supply and Sanitation Division No.2 Amritsar. The appellant was not provided the information after which the appellant filed first appeal before the first appellate authority on 05.02.2020 which took no decision on the appeal. After filing first appeal, the PIO sent information to the appellant on 18.02.2020. On being not satisfied with the information, the appellant filed 2<sup>nd</sup> appeal in the Commission on 08.05.2020.

The case has come up for hearing today through video conferencing at DAC Amritsar. The respondent present pleaded that the information has already been sent to the appellant on 19.02.2020 and the appellant also replied that he had received the information on 26.02.2020.

The appellant is absent and vide email has informed that the PIO has not removed the discrepancies pointed out to the PIO vide letter dated 28.02.2020.

As per the respondent complete information has been provided and no other information is available,. The PIO is directed to provide an affidavit that whatever information has been provided, is true, complete and no further information is available. The affidavit will be provided within a week with a copy to the Commission.

With the above order, the case is **disposed off and closed**. The Commission makes it clear that if the order is not complied by the PIO, the appellant is free to come to the Commission again.
