*High Court of Punjab and Haryana. The respondents are directed to look into the issue intently and file a reply. Meanwhile, they shall ensure that the appellant is appropriately informed.”*

The case has come up today. Sub Inspector Sh. Gyan Chand, is present. He has submitted a memo wherein a plea has been taken that the dealing official is indisposed and has to undergo a procedure in the PGIMER today. He submits that he is not in a position to comment on the subject.

The appellant is a public-spirited person. He very strongly and vehemently pleads that the directions of the Hon'ble High Court of Punjab and Haryana, as mentioned above, have been ignored by the respondents. According to him, there is a rampant corruption in the Department of Health and Family Welfare and the Police, who work in tandem on the issue.

The Commission has gone through the orders of the High Court. Very candid directions have been issued to the Director, Department of Medical Research and Education, Director, Director, Health and Family Welfare, Indian Medical Council (Punjab Chapter), Punjab Medical Council and Punjab Health Systems Corporation to upload the medical reports and postmortem reports on the website way back in 2012. The respondents had deposed before the Hon'ble High Court that their website is already under preparation and is likely to be commissioned soon.

*“The appellant had sought information on 01.05.2018 concerning various NREGA works having been undertaken in a couple of villages and some allied information.*

*The respondents have stone-walled the application and the first appeal filed by him. So much so they have failed to file a reply or attend the hearing fixed in video conferencing. The Commission finds it a blatant violation of the provisions of RTI Act. Apparently, the PIO – cum - Block Development & Panchayat Officer, Tarn Taran has rendered himself liable for penal consequences. He is, thus, issued a show cause notice to explain in a self- attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to maximum of Rs.25,000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay / denial of the information to the RTI applicant and why the compensation be not awarded to the Appellant under Section 19 (8) (b) of the Act for the detriment suffered by him.*

*In addition to the written reply, the PIO is also given an opportunity under Section 20 (1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and*

*does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte.*

*It is strange and intriguing that despite express orders and issue of show cause notice, the respondents have neither provided the information nor have filed the written reply. The Commission will be justified in imposing the penalty at this juncture. However, in the interest of fair play, another opportunity is afforded to the respondents to show cause to the above mentioned show cause notice.*

*Having heard the appellant, the order was dictated in the absence of respondents, the case having been called out a couple of times. Shri Rajvir Singh, Panchayat Secretary has appeared in person late in the afternoon. He says that he was struck up in the way.
