Post deliberation, the representative of PIO clarifies to Shri Tejinder Singh that the record relating to such colonies is available on the website of GLADA upto 2018 and no survey has been conducted by GLADA after 2018 and thus, the information related to illegal colonies after 2018 cannot be supplied.
5. Post deliberations and hearing the version of appellant and the respondent, the Bench is convinced that requisite information stands supplied to the appellant.
