2. The representative of the respondents states that the information has already been provided to the appellant through registered post dated 19.11.2020 and the same along with a letter has been sent through email dated 3.12.2020, which is taken on record.

3. After the perusal of the letters sent by the respondent-Public Information Officer it has transpired that the information as has been sought by the appellant has been supplied. Therefore, the Commission observes that no further action is required in this case. Hence, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within 10 days in case of any submissions.

ORDER

This order may be read with reference to the previous order dated, 11.9.2020 and 16.11.2020 vide which Shri Gurmail Singh, Block Development and Panchayat Officer, Samana was directed to deduct Rs 2500/- (Rupees two thousand five hundred only) from the salary of Shri Surjit Singh as penalty and deposit the same in the Govt. Treasury. He was also directed to send the compliance report in this regard.

2. The complainant has sought three points information as per his RTI application, which is reproduced as below:-

2 ਸਾਬਕਾ ਸਰਪੰਚ ਰਾਜਵਿੰਦਰ ਸਿੰਘ ਪੁੱਤਰ ਲਾਭ ਸਿੰਘ ਗ੍ਰਾਮ ਪੰਚਾਇਤ ਪ੍ਰੇਮ ਸਿੰਘ ਵਾਲਾ ਕਾਰਜਕਾਲ 1/4/2013 ਤੋਂ 30/12/2018 ਤੱਕ ਦਾ ਕੈਸ਼ ਬੁਕ, ਕਾਰਵਾਈ ਰਜਿਸਟਰ, ਮਸਟਰ ਰਜਿਸਟਰ, ਸਟਾਕ ਰਜਿਸਟਰ ਦੀਆਂ ਤਸਦੀਕਸ਼ੁਦਾ ਫੋਟੋਸਟੇਟ ਕਾਪੀਆਂ ਦਿੱਤੀਆਂ ਜਾਣ।

3 ਇਹ ਉਕਤ ਸਮੇਂ ਦੌਰਾਨ ਗ੍ਰਾਮ ਪੰਚਾਇਤ ਪ੍ਰੇਮ ਸਿੰਘ ਵਾਲਾ ਦੀ ਪੰਚਾਇਤ ਨੂੰ ਵਿਕਾਸ ਕਾਰਜ ਲਈ ਕਿੰਨੀ ਗਰਾਂਟ ਆਈ ਉਸ ਦਾ ਵਿਸਤਾਰ ਪੂਰਵਕ ਵੇਰਵਾ ਦਿੱਤਾ ਜਾਵੇ ਜੀ।”

The complete information was provided to the complainant during the last hearing dated 16.11.2020, but on his request the case was adjourned as he wants to compare the received information pertaining to the point no 2 with the original stock register. Accordingly, the respondent-Public Information Officer was directed to do the needful before the next date of hearing and the case was adjourned for 7.12.2020.

2. The appellant states that he has inspected the original stock register and requests that he has no objection, if the case is closed. Also the representative of the respondents in compliance of the orders of the Commission placed on record a copy of the challan form vide which the penalty amounting to Rs.2500/- (Two thousand five hundred only) deducted from the salary of Sh. Surjit Singh has been deposited in the State Treasury. He also requests to close the case as nothing remains pending pertaining to the RTI application.

3. After going through the case file, it has transpired that the respondent-Public Information Officer has delayed the information so he is advised to be careful in future while dealing with the RTI application. Accordingly, the Commission opines that no further action is required in this case. Hence, the case is disposed of and closed.
