The SPIO is further directed to file reply to the complaint filed by the complainant/applicant and to the show cause notice in writing and send the same to the Commission within a week and an opportunity of personal hearing will be afforded to him on the show cause notice. In case the SPIO would not file reply to the show cause notice then it will be assumed that he do not want to say anything in his defense and the show cause notice will be decided without hearing him and a penalty of Rs. 25,000/- will be imposed upon him.
